No.1/SCHEME-WP-SW/2023: Applications in prescribed format are invited for availing financial assistance under **Ima Nongthangleima Yaipha Tengbang Scheme** for women who are above the age of 40 years for FY 2024-2025.

Target group :-

- i) Widows
- ii) Divorcees
- iii) Separated Women
- iv) Deprived and marginalized women such as ex-drug users etc
- v) Single women
- vi) Single transgender women
- vii) Women belonging to low-income household and other marginalized group.


Eligibility Criteria:-

- i) She should be a resident of Manipur.
- ii) She should be above the age of 40 years.
- iii) She should not be a beneficiary of any existing Government Scheme for individual beneficiaries.
- iv) She should be living without any source of income/livelihood.

Documents required:-

- i) Aadhar as proof of Identity.
- ii) Certification that the applicant is not being a beneficiary of any existing Government Schemes for individual beneficiary, to be given by the Panchayat or Municipality or District Council.
- iii) Unemployment Certificate/Income Certificate issued by Gazetted Officer.
- iv) Matriculation Certificate or birth certificate as proof of age.
- v) Residence Certificate issued by a Gazetted Officer, with seal and signature.

Forms may be downloaded from the Departments website <https://socialwelfare.mn.gov.in> or obtained from the Directorate Office near 2nd MR Gate. The Scheme will be implemented in phases depending on the number of eligible applicants. The duly filled in application forms along with necessary documents including a copy of Bank Passbook should be submitted to the concerned District Social Welfare Officer of 16 (Sixteen) Districts of Manipur **on or before 31st March, 2024.**
