NOTIFICATION

No. 4/9/2025–SCPD: In continuation of the deliberations made during the Coordination Meeting convened and inaugurated by the Robert Kshetrimayum, IAS, the Secretary (Social Welfare), Government of Manipur, organised by the Office of the State Commissioner (PwD), Manipur on 13th November, 2025 at 11:00 A.M. at Siroi Hall, Hotel Imphal, and attended by representatives from the Health Department, Manipur, District Social Welfare Officers (DSWOs), Medical Authorities of RIMS, JNIMS, and all Chief Medical Officers, along with eminent Non-Governmental Organizations (NGOs) engaged in disability empowerment and service delivery, this office hereby issues the following Notification.

The meeting extensively reviewed strategic interventions, operational modalities, and interdepartmental convergence mechanisms required for the accelerated issuance of Unique Disability ID (UDID) Certificates, and for ensuring seamless facilitation of Persons with Benchmark Disabilities (PwBDs), particularly those with high-support needs, severe functional limitations, and bedridden conditions across the State of Manipur.

Accordingly, it is hereby notified that:

- All families of Persons with Benchmark Disabilities (PwBDs)—especially individuals with high support needs, those who are bedridden, or otherwise unable to access institutional services—whose UDID Certificates have not yet been issued, are directed to register their details on the official UDID portal: https://swavlambancard.gov.in
 - Registration may be undertaken by parents/guardians, or the families may approach the Office of the State Commissioner for Persons with Disabilities (PwD), Manipur or the concerned District Social Welfare Office for necessary assistance, in cases where self-registration is not feasible.
- Parents/guardians who have already completed online registration are requested to submit a copy of the registration acknowledgement/counterfoil to the Office of the State Commissioner (PwD), Manipur, or to the respective District Social Welfare Office for record and verification.
- Upon compilation and verification of all registration details, a comprehensive door-to-door assessment shall be undertaken, in close coordination with the Department of Health and Family Welfare, Government of Manipur, to ensure equitable and expedited issuance of UDID Certificates.

All concerned stakeholders, and beneficiary families are earnestly requested to extend their wholehearted cooperation so that no eligible person is left out of obtaining the UDID Certificate. It is further emphasized that, in the absence of a valid UDID Certificate, Persons with Disabilities (PwDs) shall not be able to access or avail the statutory entitlements, welfare benefits, institutional support mechanisms, or flagship schemes implemented by the State Government or the Government of India.
