Subject: Request for minor changes in the scheme guidelines of "Chief Minister's COVID-19 Affected Livelihood Support Scheme" and approval of the revised application form and notification

Sir,

With reference to your letter No. 6/44/2021-D(SW) Pt. dated 23<sup>rd</sup> July,2021 on the above subject, I am directed to convey approval to the following changes in the scheme guidelines as below:

- (i) Submission of Aadhaar No. by the applicants is mandatory [modification of para 3.4]
- (ii) To do away with the submission of certificate stating that applicant's life is affected by COVID-19
- (iii) The "inclusion criteria" given in the scheme guidelines is removed as eligibility criteria is clearly stated in the guidelines [ deletion of para 3.2]
- (iv) Provision for verification and identification of applicants by some relevant line departments will be included in view of the priorities to be given to some categories possessing valid registration cards, permits, license or those included in the specified verifiable list issued by the competent authority of the State Government.
- Approved Revised Application format is enclosed.
- Approved Notification with some modifications is enclosed.
- 4. Ensuring coverage of the following categories may be taken up on priority:
  - a) Street vendor under PM Svanidhi and licensed vendor
  - b) Public transport driver (Autorickshaw, Cycle Rickshaw, Tata Magic, Winger, Bus)
  - c) School Van driver
  - d) Artists/Performing Artistes availing benefits under Chief Minister's Artistesingi Tengbang
- 5. Further, it is instructed to tie up with concerned Deputy Commissioners/line departments for ensuring submission of duly filled-in application forms from prospective beneficiaries falling in the above categories.
- 6. In the phase I, application forms should be issued to only the following categories of prospective beneficiaries:

Occupation / Profession	Permit/License/Registration Card
Street Vendor / Licensed Vendor	Those Street vendors who are beneficiaries of PM Svanidhi or licensed vendors possessing license issued by Municipalities or District Councils
Public Transport Driver (Autorickshaw, Cycle Rickshaw, Tata Magic, Winger, Bus)	Those possessing permit for public transport issued by Transport Dept./Municipalities/District Councils
School Van Driver	Those possessing permit for School Van issued by Transport Department or Certificate issued by School Authority concerned
Artists /Performing Artistes	Those pensioners/awardees included in the beneficiary list of Chief Minister's Artistesingi Tengbang (CMAT)
