No.1/14/CNCP/ICPS-(SW):In pursuant to approval of the State Government conveyed vide letter No. CSSS-206(4)/1/2021-SW-SW dated 3/02/2021 and in exercise of the powers conferred under Rule No.88 (1)&(2) of The Juvenile Justice(Care & Protection of Children)Model Rules,2016, application in plain paper is invited from eligible persons for appointment of Members for reconstitution and filling up of vacant post of Child Welfare Committee(CWCs) for the following districts;



Eligibility:-

A person who is above the age of thirty-five years and shall have a minimum of seven years of experience of working with children in the field of education, health, or welfare activities or should be a practising professional with a degree in child psychology or psychiatry or social work or sociology or human development or in the field of law or a retired judicial officer.

The following Terms & Condition shall be applied:-

- No Person shall be appointed as a member of the Committee unless he possesses such other qualification as per the Act and Rules.
- No person shall be appointed for a period of more than three years as a member of the Committee.
- The appointment of any member of the Committee shall be terminated by the State Government after making an enquiry ,if:
 - He /She has been found guilty of misuse of power vested on him under this Act.
 - He /She has been convicted of an offence involving moral turpitude and such conviction has not been reversed or he has not been granted full pardon in respect of such offence.
 - He/She fails to attend the proceedings of the Committee consecutively for three months without any valid reason or he fails to attend less than three-fourth of the sittings in a year.
- A member selected for the Committee should not:
 - Be holding such full-time occupation that may not allow the person to give necessary time and attention to the work of the Committee as per the Act and rules.
 - Be associated with any Child Care Institution, directly or indirectly, during his tenure as a member of the Committee or have any other conflict of interest.
 - Hold any office in any political party during his tenure
 - Be insolvent
- The person applying for the post of the CWCs Committee may mention the respective district of the post applied for.
- The applications along with experience certificate must be submitted to the Director, Department of Social Welfare, Government of Manipur, Directorate Complex near 2nd M.R Gate North A.O.C Imphal -795001, Manipur on or before 14/10/2021 by 4:00 p.m.
